



## Update for key stakeholders

17 September 2021

### COVID cases

We had 1,601 new cases in the seven days to 12 September. The infection rate is 500.5/100,000 across the NHS Highland area: 552.5/100,000 in Argyll and Bute and 479.5/100,000 in North Highland.

We have 23 patients in hospital with COVID-19, including 6 ITU. We have 7 ITU beds, currently flexed up to 9, of which 3 are occupied with non-COVID-19 patients.

There have been 188 recorded deaths in the NHS Highland area since the start of the pandemic: 113 in Highland and 75 in Argyll and Bute. This represents an increase of 4 in the last 7 days.

### Vaccination

94.4% of people over 18 in the NHS Highland area have received one COVID vaccination, compared to a Scottish average of 91.6%. 87.5% have received two doses, compared to a Scottish average of 85.2%. You can view progress on the national [vaccination programme online here](#).

We have plans in place for vaccination of 12-15 year olds and booster vaccinations for relevant groups, and these will be confirmed next week.

### Midwifery cover

Recruiting midwives is currently a national challenge, and we are working on several fronts to overcome it. This includes bringing qualified midwives currently working in other roles back into midwifery on a temporary or part-time basis, working with local communities to promote remote and rural areas as a place to live and work, and partnering with Napier University to offer placements on a 'fast track' course.

The West Highland Free Press stated this week that pregnant women could not be treated at Portree Hospital unless a doctor was on duty. We wish to clarify that midwives on Skye, as with the other community midwifery units in Fort William and Caithness, are available 24/7 via our on-call out-of-hours (OOH) service.

Triage is through the local midwifery team and Raigmore Hospital OOHs. Pregnant women are seen in the CMU in Mackinnon Memorial Hospital in Broadford, however if it was an acute presentation in Portree, or anywhere in Skye, the midwife would respond with back-up from the Rural Practitioner Team, local GP and the Scottish Ambulance Service.

The full statement we sent to the paper in response to their enquiry is:

*The NMC states that only a registered medical practitioner or a practicing midwife can provide assessments and pregnancy-related care for pregnant women. NHS Highland has a pathway for pregnant women in which women over 16 weeks pregnant must be referred to either MacKinnon Memorial Hospital or Raigmore Hospital maternity services.*

*The use of the term “legal” was incorrect in this context but is often used as a general term for the public when practitioners are explaining the process.*

*No advanced practitioner should work outwith their sphere of competence and maternity care is very specialised. From a safety perspective and to ensure care is not delayed they would always be signposted to MMH or Raigmore. If a pregnant woman presented to Portree MIU in an emergency, appropriate care would be delivered while awaiting emergency ambulance transfer as per the pathway.*

## **Scottish Government Non-Executive Directors**
